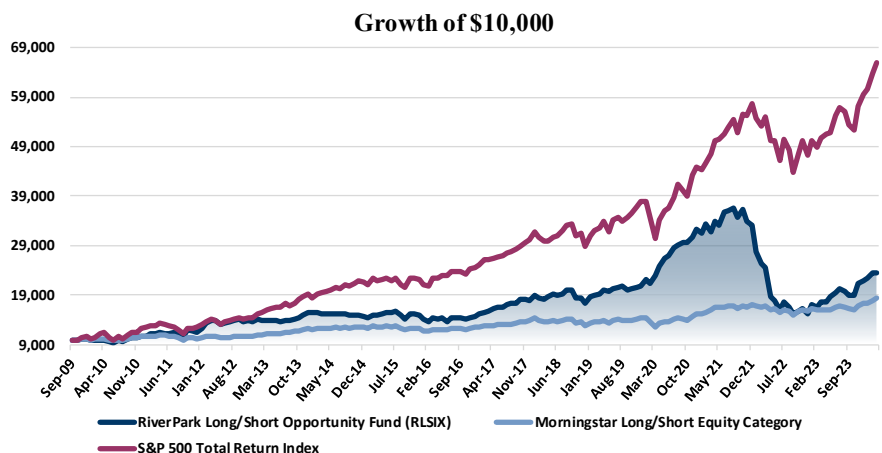
## Investment Objective

The RiverPark Long/Short Opportunity Fund seeks long-term capital appreciation while managing downside volatility.

## Investment Strategy

The RiverPark Long/Short Opportunity Fund invests long in equity securities that the Adviser believes have above-average growth prospects and sells short equity securities the Adviser believes are competitively disadvantaged over the long term. The Fund expects to invest primarily in the securities of U.S. companies, but it may also invest outside the U.S. The Fund is an opportunistic long/short investment fund. The Fund's investment goal is to achieve above average rates of return with less volatility and less downside risk as compared to U.S. equity markets.

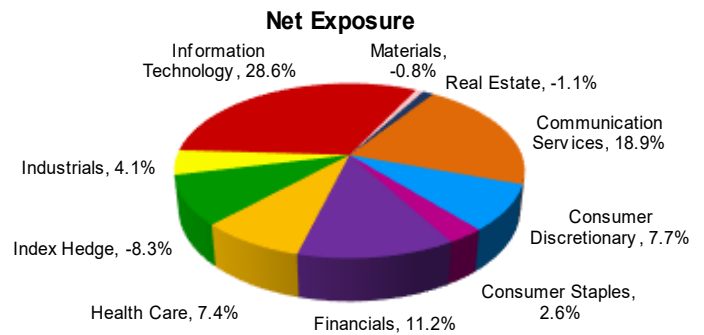
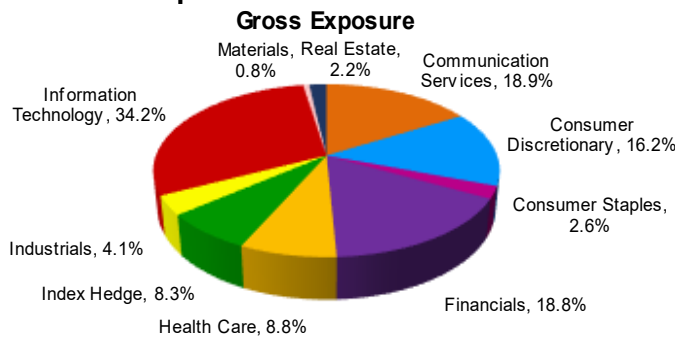

<sup>5</sup> Risk Measurement Statistics: Max Drawdown measures the single largest peak to trough decline in an investment's or index's net asset value since inception of the investment vehicle. Different indices and investments will experience drawdowns over different time periods. However, comparing max drawdowns over a common time period among multiple investments or indices provides a common basis for comparing two or more sets of data. The max drawdown for a particular index may be different than the max drawdown presented if it were to include the entire period of such index's existence rather than the period set forth above. Since the Fund was converted from a partnership with only historical monthly performance, the max drawdown is calculated based on monthly performance information. Down Market Performance measures the average monthly performance of the Fund as compared to the average monthly performance of the Fund's benchmark, the S&P 500, for the months in which the benchmark lost money. Gross exposure is calculated by adding the percentage of the Fund's equity invested in short sales to the percentage of its equity used for long positions. Net exposure takes into account the benefits of offsetting long and short positions and is calculated by subtracting the percentage of the Fund's equity capital invested in short sales from the percentage of its equity capital used for long positions. The Sharpe ratio is calculated by subtracting the risk-free rate, such as that of the 3-month U.S. Treasury Bill, from the rate of return for a portfolio and dividing the result by the standard deviation of the portfolio returns.

The S&P 500 Total Return Index is an unmanaged capitalization-weighted index generally representative of large companies in the U.S. stock market and based on price changes and reinvested dividends. Morningstar Long/Short Equity Category portfolios hold sizeable stakes in both long and short positions in equities, exchange traded funds, and related derivatives. Some funds that fall into this category will shift their exposure to long and short positions depending on their macro outlook or the opportunities they uncover through bottom-up research.
